




## 2025 PRACTICE FIELD INFORMATION.....



Local sheep ranchers, Terry and Dee Ann Goedert, have graciously agreed to provide **mature FARM FLOCK** ewes for handlers to "work" during their stay at the Meeker Classic. They will have their mature farm flock ewes available for the practice field. These will be a combination of Hampshire and Targhee cross ewes. We so appreciate this opportunity and cooperation from some of Meeker's finest! ***Please remember that Terry & Dee Ann have the right to refuse future use of the sheep should handlers overwork or abuse their privilege.*** This is at their complete discretion.

- Sheep:** Mature Farm Flock Ewes (Predominantly Targhee & Hampshire Ewes)
- Fee:** \$40 for ONE Session – 30 minutes Maximum; No splitting session times

- Available:** Monday, September 1, 2025 – afternoon only

### **Guidelines:**

1. Practice Field by **Appointment** ONLY
2. Only "OPEN" level dogs please
3. Practice field may be "closed" if the sheep are over-worked or heat stressed
4. Handlers will sign Waiver of Liability & Release (below)
5. ANY sheep that dies or suffers a bite injury during a practice run will be the responsibility of the handler to compensate the owners veterinary expenses of at a rate of \$350 per head. No exceptions!

Directions to Practice Field (from Meeker Classic trial field).

**1260 County Road 8, Meeker \*\*Google Maps will take you to the wrong place**

**Follow the directions below:**

- Head East on Hwy 13 out of Meeker via Market Street
- Go 1.4 miles – turn right on County Road 8
- Go 1.2 Miles on County Road 8 – **TURN RIGHT AT THE GREEN CABINS & CROSS BRIDGE**
- Follow the road to the right past the Green Cabins
- Past a tan log house on the right and then a stucco house on the left -don't turn left towards that house
- There is a sign with the **GOEDERT** name and address just across from the shop
- Take a right down lane that goes through a hay field (you will be heading west – back towards town)
- Their house is a two story red house under 2 big willow trees – (their place is .8 mile from the bridge when you cross the river
